**Subject: Extended Secretariat Meeting of the ITGOA, CHQ to be held on  
04.01.2015 - regarding.**

The ITGOA, CHQ wishes a very happy and prosperous new year 2015 to all the members of this esteemed organisation.

We also congratulate all the members of 2008, 2009 (leftover cases) and 2010 batch who have been promoted as DCIT in the senior time scale w.e.f. 01.01.2015 vide CBDT Notification No. 19 of 2015. But unfortunately, the promotions have not been accorded to a large number of officers also due to deficient APARs. We need to take up the task of collecting complete APARs of all these officers as soon as possible and make their promotions in STS.

Comrades, you are aware that the Extended Secretariat Meeting of ITGOA, CHQ is scheduled to be held on 04<sup>th</sup> January, 2015 (Sunday) at 12.00 Noon in New Delhi to transact the various agenda items as per the notice dated 04.12.2014. It is to inform you that the venue of the said meeting has been fixed at the **Income tax office, E-2 Block, Civic Centre, New Delhi.**

Beside other issues, one of the agenda items of the meeting is to discuss the course of action to be taken for promotion to the cadre of ACIT vis a vis implementation of the judgment in the case of Union of India vs. N.R. Parmar. In order to have a meaningful deliberation on this issue, it will be important to know the present status of implementation of the judgment and consequential revision of the ITO seniority lists in all the regions. We are very happy to mention that the task of such revision has been completed in UP(East), Kerala and NER. It is learnt that this exercise is likely to be completed soon in some other regions also. However, we are still away from the completion of the task nation-wide and every single day passes by waiting for the long-

pending promotion in the cadre of ACIT adds a fresh more drop in the mounting frustration of our members.

In the above scenario, the following issues may kindly be discussed/intimated in the meeting dated 4<sup>th</sup> January, 2015 by all the Units:

1. By which date the work of revision in seniority and holding of review DPCs as per the CBDT advisory is likely to be completed in the Unit.
2. Whether there is any problem being faced in the above exercise. If so, whether any support/assistance of the CHQ is required.
3. The opinion of the Unit in holding the DPC for promotion to the cadre of ACIT- whether we should wait for DPC till the revision of seniority nationwide or we should make immediate efforts for holding of the DPC for promotion subject to revision of seniority as per the implementation of the NRP judgement.

The Presidents/General Secretaries of all Units are again requested to attend the meeting or send representatives with all these information to make the deliberation concrete and decisive.

I do request all the Units to inform their attendance in the meeting at least one day before, by sms, for the convenience of proper arrangement of meeting.
