Subject: Amendment of existing Transfer/Placement Guidelines of IRS officers – regarding.

The above referred matter was discussed in the Quarterly Review meeting of the Chairman, CBDT with the representatives of JCA on 14-10-2014. The Chairman, CBDT, also expressed the need for amendments in the existing guidelines and requested the representatives of ITGOA to submit the proposed amendments of the existing 'Transfer/Placement Guidelines for officers of the Indian Revenue Service, CBDT' to the Board for consideration.

I, on behalf of CHQ, propose some of the amendments required in the Transfer/Placement Guidelines issued on 16-02-2010 as below(The Transfer/Placement Guidelines for officers of the Indian Revenue Service, CBDT, 2010 is enclosed for ready reference):

1. Clause 3.4 is to be read as "*Group-'B' officers on promotion to the grade of ACIT shall be transferred out of the region **only when there are no vacancies in that region** and except in those cases where the officer has less than **five years** of service left at the time of promotion.*"
2. Clause 3.5 is to be read as "*Officers who have **5 years or less** service left shall be posted to the station/region of their choice to the extent possible.*"
3. Clause 4.6 is to be read as "*All postings in the Board.....Central Processing Centre(CPC), Settlement Commission and **International taxation & Transfer Pricing** shall be treated as exempt.....*"
4. Clause 4.8 is to be read as "*The cooling off period for being posted again to the same station/region will be **2 years reckoned from AGT to AGT exercises and the periods spent in exempt postings will be counted as period of stay at that station/region.***"
5. Clause 6.1 is to be read as "*Cases of postings on medical/compassionate/educational grounds will be considered sympathetically and **in accordance with the extant instructions of the Government of India** by the Placement Committee.*"

6. Clause 9 is to be read as *“Subject to the availability of vacancies, Principal Office Bearer(President, General Secretary and Treasurer) of the recognized Associations/Federations at unit/circle level may be allowed to continue at the same station/region till the next BGM at unit/circle level of the respective Association/Federation.”*

There may be suggestions to include more stations in clause 4.3(i)(a) & (b) and also to exclude/include postings which are to be treated as exempt in clause 4.6.

There may be many more suggestions from all our members regarding changes in the existing ‘Transfer/Placement Guidelines for officers of the Indian Revenue Service, CBDT’. All the Unit leadership are requested to discuss the matter within the Unit and express their views/opinions/suggestions on the subject as soon as possibly enabling the CHQ to compile and submit it before CBDT. **The views/opinions/suggestions may be forwarded to the CHQ by 11-11-2014** to Sri Srikant Pandey, Asstt.
