
Respected Sir,

The Confederation of Central Government Gazetted Officers' Organisations (CCGGOO) is an apex level organization embracing, in its fold, a number of recognized Gazetted Officers' Organisations, of the Central Government departments, such as Railway Promotee Officers, Income Tax Gazetted Officers, Audit and Accounts Officers of Indian Audit and Accounts Department, Pay and Accounts Officers(Civil), Postal & Telecom financial Accounts Officers, Zoological Survey, Botanical Survey, Customs Preventive Officers, Central Excise Superintendents, Indian Ordinance Factories Gazetted Officers, DRDO Technical Officers, DGQA Engineers, CPWD Engineers, Postal Officers, Marine product Export Development Authority promotee Officers, Statistical Gazetted Officers, IRS promotee Central Revenue Officers etc. It represents more than 85,000 Gazetted Group B and promotee Group A Officers.

We have been given to understand that the officers and employees of the Income Tax Department have embarked on the path of agitation, in pursuance of the 5(five) Point Charter of Demands served upon the Central Board of Direct Taxes (CBDT), under the banner of the Joint Council of Action (JCA) of the Associations representing 97% of the entire workforce in the Department. The JCA has launched a series of nation-wide agitation programmes since 09-09-2015, **culminating in one day strike action on 8th October 2015**. We are also given to understand that the JCA has decided to intensify the agitation after 08-10-2015 if the issues are not resolved immediately. It is our submission that the issues involved should be serious ones in view of the action being contemplated by the majority of the officers and employees of the department.

In the above-mentioned scenario, we solicit your kind intervention in the matter in directing the Central Board of Direct Taxes to resolve the issues without loss of time so that the normal functioning of the vital department is not affected by such agitations.
