Dear Comrades,

Sub: *Intensification of Ongoing Agitation*

This is to intimate to all our members that though the members of JCA all over the country have participated wholeheartedly in all the programme of actions in the ongoing agitation since 01-04-2017, the CBDT is still showing reluctance to initiate a meaningful dialogue so that the issues can be resolved.

It is to reiterate that only a sustained and intensive agitation can achieve our demands and so, all the Units/Circles of ITGOA/ITEF are requested to observe the Half-day walk-out from 2.00 PM on 24-05-2017 as decided earlier ensuring the active participation of all its members.

The further course of action in regard to the intensification of agitation was decided in the Central JCA meeting held on 03-05-2017 and again on 22-05-2017 at New Delhi. The said meetings decided to intensify the programmes of agitation commenced from 01-04-2017 including the following modes:

- i) **Non-submission of reports (except the Parliamentary Questions and Audit Queries) from 25-05-2017.**
- ii) **Not to conduct/take part in search & survey operations including TDS survey, recovery survey from 25-05-2017.**

The intensification of the programme of agitation had been informed to the Chairperson, CBDT vide the letter of Central JCA, dated 05-05-2017 and again on 24-05-2017 (copy of both the letters are attached herewith). All the Units of JCA are requested to submit a copy of the same to the respective Pr.CCSIT for information.

Further, it has been reported to the Central JCA that the already adopted mode of agitation of the 'stoppage of outsourcing' from 1<sup>st</sup> of April, 2017 has created trouble in some of the charges where there are no official/much less than the required number of officials deployed by the Department. The Central JCA, in its meeting dated 22-05-2017 has decided that the State JCA Units will identify all those charges where the statutory functions are getting hampered due to the acute shortage of man-power within 29-05-2017 and necessary steps will be taken to sort out the problems faced by our members in consultation with the Central JCA.

All the Units/Circles of ITGOA/ITEF are requested to ensure that above programmes of agitation are observed with cent per cent participation of its members.
