Dear Comrades,

The following issues are communicated for information and necessary action by all the Units:

- 1) The officers of 2006 batch of IRS Officers, who were promoted to STS on 20-06-2012, are appointed to the grade of Joint Commissioner of Income Tax on ad-hoc basis vide Order No. 140 of 2015 dated 13-08-2015 (attached along with). ITGOA congratulates all its members who have been promoted to the grade of JCIT. But as a matter of fact there are officers who are promoted to STS subsequently on a later date but are given the seniority along with the officers promoted on 20-06-2012. We apprehend that some of these officers may be overlooked and not given promotion to the grade of JCIT in this Order. I do request all the Units to collect the details of such officers, if any, amongst our members and send it to the CHQ as early as possible so that the promotion can be given to all these officers and fix their seniority along with the officers promoted vide the Order No. 140 dated 13-08-2015.
- 2) The process of regularization of the Ad-hoc promotion of 2002 batch in the grade of JCIT has been delayed much beyond our anticipation. The major hurdle behind this delay is the various technical queries and objections raised by UPSC. The very recent objection sent by the UPSC is regarding the permission of DoPT in extending the ad-hoc status of JCIT after one year which was not at all sought for by the CBDT for any of the 2002/2003/2004 batches. The file has been moved to DoPT asking retrospective permission of continuing the ad-hoc status of 2002 batch as JCIT very recently after the objection of UPSC is received. The file for such retrospective permission for continuing the ad-hoc status of 2003 & 2004 batches have also been prepared to move to the DoPT now. ITGOA is trying to pursue DoPT, with the help of O.P.Sinha Committee, to get such permissions early. In the mean time, the deficiency list of 2003 batch officers, with a view to prepare the dossier for regularisation as JCSIT, has been uploaded on 13-08-2015 (attached along with). All the Units are requested to complete the removal of deficiency as early as possible and send the CHQ a detail of such complete APARs to take it up with the competent authority.

- 3) The office of DGIT(HRD) will convene a workshop on the implementation of NRP judgement in various regions at New Delhi on 17-08-2015. The regions that are facing difficulty in the implementation of NRP judgement are requested to attend the workshop. We also request the Units leadership to take up the matter with the respective Pr. CCIT and ensure attendance of their regions in the said workshop.
- 4) A meeting of the Central JCA was convened at New Delhi on 12-08-2015 as per the notice issued on 08-08-2015 to discuss and decide upon the course of action to be taken in protest against the inordinate delay in the promotion from ITO to ACIT and other issues. The decision of this meeting will be intimated to all through the JCA circular soon.
