Dear Comrades,

As you all know that the JCA has embarked upon the path of agitation in the issues of promotion to the cadre of ACIT and others. It is to be reiterated that the promotion in ACIT cadre could have been done long before had the process not been interfered regularly by a section of DR Officers. This particular section has wrongly interpreted the rule of 1:1 Quota for the DR & PR Officers and consistently been objecting on more number of promotions in a particular R.Y. than the number of direct recruitments. The CBDT too, as always, is playing the role of patronizing this section of DR officers. Also, it has become the practice of the Department, both in all India and local levels, to exercise favouratism for a section of DR officers in the Transfers & Placements every year. The JCA has requested the CBDT time and again to take a call to reign in such ulterior motives which otherwise may permanently tarnish the impartial image of the Board.

In the above context, all the members of JCA feel that this step-brotherly attitude shown to the promote officers on part of the CBDT must be stopped for the betterment of the Department itself and we need to represent the facts, regarding the discrimination between the DR and PR officers, to all the authorities concerned immediately.

It was also been intimated to all that as per the demand of ITGOA regarding Amendments in the T & P Guidelines, 2010, a committee had been formed by the CBDT to suggest the required amendments. The 1st meeting of the committee was held on 21-08-2015 and the next meeting is scheduled to be held on 28-09-2015(the notice of the meeting is attached herewith). It is requested to all the Units of ITGOA to provide the following information to the CHQ by 25-09-2015 so that the lopsided practice of Transfers and Placements between the DR and PR officers can be represented before the committee and also to the higher forums than CBDT, if required.
