**Subject: Transfer & Postings in the cadre of newly promoted JC&IT- Order  
No.70 of 2014 - regarding**

Kindly refer to the Order No. 70 of 2014 dated 16.05.2014 making transfer orders of the Joint Commissioners of Income Tax promoted vide CBDT Order No.186 of 2013 dated 01.10.2013.

In this regard, it is to submit that this transfer order covers only those officers who were promoted vide order no. 186 of 2013. The officers, promoted subsequently vide orders no.18 & 27 of 2014, were not considered in the said transfer Order and we request your goodself to pass the posting order for these officers also.

Further, on perusal of the order, it has been found that the cases falling under retirement zone, education ground, compassionate ground, cases of stay of less than 2 years and working spouse ground have been considered. We are thankful for such sympathetic attitude of the Board and we believe that it shall remain in future transfer orders as well. However, we have found that certain similarly situated cases which are not considered favourably in the Order No.70 of 2014. The details of such cases are as under:

3	Pavan Kumar Sharma	04531	NWR	Gujarat	(i) Child studying in 10 <sup>th</sup> in the academic year 2014-15. (ii) Old aged ailing father and other family responsibilities.	Covered under clause 6.1 of the TPG
4	Subhrajyoti Bhattacharjee	04532	NER	WB	(i) His son Master Sagarnil Bhattacharya is at class - XII at present in Shillong [under Guwahati Region ]. (ii) His wife is in a non-transferrable job at Shillong under a state govt.-aided HS School.	Covered under clause 6.1 of the TPG

It is, therefore, requested that all the above cases may be sympathetically considered for suitable modification in transfer orders.
