**Subject: Condemnation and demand for action in respect of the incident concerning**  
**Shri Mirza Azhar Beg, Dy. Director of Income Tax (Investigation), Udaipur,**  
**Rajasthan– regarding**

Kindly refer to the above.

You must be aware of the unfortunate incident happened at Udaipur(Rajasthan) where some police personnel barged into the house of Shri Mirza Azhar Beg , DDIT (Inv), Udaipur on 05.05.2017 and misbehaved with his family members in his presence. The police personnel threatened the whole family of dire consequences. An FIR was filed by Shri Mirza Azhar Beg, DDIT immediately but no significant action was taken by the Police Department. The excuse offered by the police authorities that it was a case of mistaken identity and the police personnel entered the house of Shri Mirza Azhar Beg wrongly instead of entering some other premise in the same locality was not seem to be tenable as the DDIT disclosed his identity immediately after the police personnel entered his house.

The whole incident is a clear case of misuse of power by the Police Department in connivance with an unlawful corrupt section of businessman community and the excuses provided by the higher-ups in the Police Department are not unacceptable to the entire fraternity of Income Tax Department. It will be demoralizing for the officers/officials of the Income Tax Department, especially when we are passing through a very crucial phase of post-demonetization and unearthing of black money.



The Central JCA condemns the deplorable treatment meted out to Sri Mirza Azhar Baig, DDIT(Investigation) by a section of the state police authorities of Udaipur, Rajasthan in strongest terms.

We would request the CBDT to ensure that strict action against the erring police officials be taken and we feel that whatever has been done so far falls short of the desired level of measure.

This is for your kind consideration and necessary action.
