**Sub: Transfer & Posting orders Addl. CIT/JCIT - matter regarding.**

Kindly refer to the above.

I would like to mention that the issue of considering the cooling off period for 2(two) years counted from AGT to AGT was raised in the QRM dated 11-02-2015 and the official side agreed to it. But in practice, though all the officers in the cadre of DCIT/ACIT, who were transferred out in 2013, were sent back either to their home-stations or at the station of their choices in AGT-2013, **the officers in the cadre of Addl.CIT/JCIT who were transferred out of their home-stations in 2013 were not considered.** We were given to understand that the posting of all the officers at their choice stations who were transferred out in 2013 would leave some of the regions as deficient due to huge vacancies in the Addl.CIT/JCIT cadre.

Moreover, one officer, namely **Sri Saumyajit Das Gupta(02543), JCIT**, who was transferred to the Chennai charge from the WB charge in 2012 and opted to be transferred back to the WB charge in AGT, 2015, was posted in the Bihar & Jharkhand charge only(the copy of representation is enclosed).

And, **Sri Umesh Takyar(04598), JCIT**, who had been posted to the NWR charge vide AGT, 2014 after serving more than 4 years in UP(W) charge, while his first choice of posting was the Delhi charge only, was not considered in AGT, 2015 also(the copy of representation is enclosed).

The Screening Committee Meeting for the ad-hoc promotion of the 2006 batch officers in the cadre of JCIT was convened on 28-07-2015 and the order is supposed to be passed soon. The eligible officers were also asked to fill up the options for their choice of posting.

In such a scenario, we request you to transfer back all the officers in the cadre of **JCIT, who were transferred out in 2013, to their home-stations/choice of postings** and transfer out the officers of 2006 batch to fill up the vacancies in the deficient regions, as far as required. A list of the officers (Addl.CIT/JCIT) who were transferred out in 2013 and opted to be transferred back to their home-stations is annexed along with. The cases of any such officer, whose names are not mentioned in this list, may kindly be considered too. We would also request you to consider the cases of **Sri Saumyajit Das Gupta and Sri Umesh Takyar for postings in the WB charge and Delhi charge** respectively.

This is for your kind consideration and necessary action.
