**Subject: Annual General Transfers, 2015- Reminder**

**Ref: Communication of ITGOA dated 18-02-2015.**

Kindly refer to the above-mentioned Communication of ITGOA dated 18-02-2015.

It was decided in QRM dated 11-02-2015, as demanded by JCA, that the AGT, 2015, in all cadres, would be completed by 31-03-2015. It was also decided in the same meeting to consider the **cooling off period of 2(two) years from AGT to AGT**. As it becomes the duty and responsibility of CHQ to represent the option/choice of posting of our members before the Board and pursue, **we requested all the Units to send information to CHQ by 27-02-2015**, in the enclosed proforma, regarding the transfer-options given by our members of that respective region. But unfortunately, till today, **we have received the information in this regard from 6(six) Units only, namely TN, WB, Rajasthan, KTK, Kerala and Nagpur**. Moreover, **as some of the Units expressed their reservation**, in the MCM at Indore on 23<sup>rd</sup> & 24<sup>th</sup> of February, 2015, **in sharing of information between the CHQ and the general members directly**, so though a good number of our members from various Units directly sent their representations to the CHQ, we have consciously decided to compile data on the basis of information sent by the Unit leadership only. In our communication dated 18-02-2015 also, the members were requested to provide their details of transfer-options to the respective Unit leadership for compiling the data and sending it to the CHQ.

In such a scenario, **the CHQ will be compelled to submit incomplete information before the Board and our members may suffer for that**. As the Board has initiated the process of AGT, 2015 in all cadres, we are already late in representing the cases of our members. May I request the Units once again to go through the Communication dated 18-02-2015 and **send the required information to CHQ by 10-03-2015**? The above details may kindly be sent to Com.
