Subject: Vigilance Matters against members- asking for details.

Please refer to the above.

Yoyr attention is invited to the minutes of the Extended CHQ meeting held at New Delhi on 04/01/2015. In the said meeting it was decided that all the Units shall provide the details of pending vigilance matter so that a comprehensive data base may be prepared at the CHQ and the matter may be taken up with the competent authority for the early resolutions of the matters and seeking directions from the competent authority to the authorities below to complete the proceedings in a time bound manner.

Our members face unnecessary harassment at the hands of our own department for the frivolous complaints filed against them by the interested persons for reasons which have no grounds. To mitigate this grivenance of our members the Units are requested to get the details as per the prescribed proforma at the earliest. A person may be deputed by each unit to collect the same and the name , telephone number and e-mail address of such person may be communicated to CHQ so that necessary coordination may be maintained by CHQ with that person.

It may be mentioned that proforma in Annexure B has been inserted to get empirical details regarding the time taken for the completion of the proceedings and the turmoil which our member has to undergo for the period in which proceedings against him were pending. Further, it is also important to impart activism to our Units so that pressure can be maintained on the controlling and competent authorities to compel them to initiate action against persons leveling frivolous accusations against our members. This will instill a kind of fear in these persons and can work as a deterrence against them for filing frivolous complaints. The likely action which the controlling officer can take against these persons is under various provisions of IPC like that of criminal intimidation and causing obstruction in the discharge of the official duties of the officer and also criminal defamation.

Please accord this matter TOP PRIORITY as it is being done in the interest of our members suffering harassment and losing peace of mind.
